The Chancellor welcomed the new Vice-Chancellor, Professor Robin Pollard, to his first meeting of Council.

The Chancellor also acknowledged the major contribution made by Dr John Hay in the role of Interim Vice-Chancellor.

The success of the Governor-General's visit to the University on 10 March was noted. The Chancellor indicated that an acknowledgement letter received from the Governor-General would be circulated to Council members.

#### 8. Vice-Chancellor's Report

#### 8.1 Overview

The report from the Interim Vice-Chancellor was NOTED. The report provided an update on: operational activities; staff, student and alumni achievements; research; and visitors to the University.

The Vice-Chancellor highlighted the Semester One student numbers, in particular the overall rise of 13% in new students and the 6% increase in total students compared to 2015. Work would be done to isolate the impact of the recovery from the Canterbury earthquakes, the demographic trends and the qualifications reform in order to inform forecasting for future years.

The opening of the new growth chambers and plant science laboratory at the Field Research Centre was noted. The facility adds significant capability in the plant sciences area.

A reciprocal visit in March by a University delegation to the University of Tasmania and Tasmanian Institute of Agriculture is likely to result in a joint horticultural science programme, a joint sub-degree programme, student exchanges (undergraduate and postgraduate) and staff exchanges. It was also noted that the 2017 World Farm Management Congress may be held at the University of Tasmania and provide an opportunity for Lincoln University to engage with attendees around farm management capability.

#### 8.2 Conferment of Degrees and Presentation of Diplomas

The report was NOTED, and the Acting Chair of the Academic Board spoke to the report.

That Council approve the revocation of the Diploma in Natural Resources awarded to Louise Mary Hamilton (1072952) so that she may use the credits towards the Bachelor of Landscape Architecture.

#### 9. LUSA President's Report

The President highlighted initiatives to seek feedback from students on ways to improve the student experience. An all student ideas session had been held at 'The Workshop' on 3 March and the information will be used to develop an online Student Experience Survey which will be sent out to all students at Easter. Suggested improvements had included: more outdoor furniture, improved lighting, provision of a swimming pool, more bars and cafes, and bringing external businesses on campus.
