



## 6. **Chancellor's Report**

The report from the Chancellor was NOTED. The report listed the Chancellor's major commitments since the previous meeting.

The Chancellor noted that he would be attending the Universities New Zealand meeting in Palmerston North on 8 December. The Chancellors and Vice-Chancellors would farewell the Hon Steve Maharey upon his retirement from the role of Vice-Chancellor of Massey University.

## 7. **Vice-Chancellor's Report**

### 7.1 **Strategic Risk Register**

The report was NOTED.

The net risk rating for the "inadequate progress on the Refreshing Lincoln agenda" item had been reassessed from 'red' to 'amber', reflecting the implementation of a strong project management process for the various workstreams.

### 7.2 **Health and Safety Update**

A monthly report for November was NOTED.

No notifiable injuries or incidents were reported. Work is continuing on the campus lockdown plan, addressing the issues identified during the recent simulation.

### 7.3 **Biosafety Update**

The conferral date for the qualification to be awarded to Ms Sonya Low (1017566) was considered. Council's preference was for the conferral date to be backdated to reflect the academic currency of the qualification.
