MINUTES OF A MEETING OF THE LINCOLN UNIVERSITY COUNCIL

1. Welcome and Apologies

An apology for absence was received from Mr Macfarlane.

The Chancellor welcomed Mrs Janice Fredric to her first Council meeting following her ministerial appointment to Council.

2. Disclosures of Interest

There were no disclosures of interest.

3. Confirmation of Minutes of Previous Meeting held on 30 May 2017

It was suggested that the discussion of the Strategic Risk Register item be moved to the In-Committee meeting.

5. Notice of Items of General Business

There were no items of general business notified.

6. Chancellor's Report

The report was NOTED.

The Chancellor highlighted:

- The ministerial appointment of Mrs Janice Fredric to Council for a term of four years, effective from 12 June 2017.
- The recognition in the Queen's Birthday Honours List for former Chancellor Mr Tony Hall who was made a Companion of the New Zealand Order of Merit (CNZM) for services to education and sport in the Canterbury region and nationally.
- The influential visit by Dr Aalt Dijkhuizen, International Panel member of the Transformation Board, including meeting with three Ministers and key political stakeholders for the sector in Wellington on 12 June.
- The Kea World Class NZ Awards made to two outstanding recipients with connections to Lincoln University: Sir Rob Fenwick and Dr Phil Rolston.

7. Vice-Chancellor's Report

7.1 Vice-Chancellor's Update

The report was NOTED.

The Vice-Chancellor highlighted the University's improvement for the fifth year in a row in the QS World University rankings. The latest ranking of 319 is an improvement of 24 places from last year and an overall increase of more than 160 places since first entering the rankings in 2014. Efforts to address the academic credibility factor are needed to achieve further improvement in the rankings.

Council acknowledged the recognition accorded to Professor David Simmons in being welcomed as a Fellow of the International Academy for the Study of Tourism and the prestigious appointment of Mr Crawford Falconer as the United Kingdom's Chief Trade Negotiator.

7.2 Health, Safety and Compliance Report

The monthly report for May was NOTED.

The report covered the following matters:

- A small spike in lost time injuries in April, largely due to falls/trips/slips on un-even surfaces resulting in sprains or torn ligaments.
- An improvement in reporting of incidents, with further work to be done in relation to reporting from the farms.
- Efforts being made to obtain more meaningful reporting data and review the current on-line incident reporting system.
- Progress on the campus lockdown project, with the installation of the hardware nearly complete, and testing and communications of the new procedure to follow.

- The positioning of the temporary Dangerous Goods Store behind the Burns building. A specific Health and Safety group for Burns building has been set up.
- No corrective actions had resulted from the Ministry for Primary Industries' external audit of the LU Containment Facility 489 on 3 May.

The Pro-Chancellor indicated that she would arrange another Health and Safety campus tour and any available members would be welcome to participate.

7.3 Academic Board Report

The report was NOTED.

The report outlined the efforts made to encourage Faculties and Divisions to present proposals through the established academic processes for changes to academic programmes and/or proposed new programmes. The Academic Board expected to consider academic proposals at its next two meetings.

The ongoing work on the Academic Quality Agency (AQA) Cycle 5 Follow-up Project was noted, with staff being committed to addressing the audit report's recommendations and additional observations. A report is due to be submitted to AQA at the end of 2017 on the University's progress.

7.4 Conferment of Degrees and Presentation of Diplomas

The report was NOTED.

8. Report of Ahumairaki Meeting of 8 June 2017

The report was NOTED. It provided an update on the activities of the Director Kaiārahi Māori, Te Taumutu Rūnanga and Te Awhioraki.

The Convenor reported on the proposal to enhance the status of the Ngāti Moki Trophy awarded each year to a person who has shown considerable leadership and commitment to Māori development and advancement at Lincoln University. The awarding would be aligned with the process for premier awards through the Awards Committee of Council, with initial consideration from Ahumairaki. The Trophy would normally be presented at both Rā Whakamana and Graduation by representatives of Te Taumutu Runanga and Lincoln University.

Council RESOLVED:

That the awarding of the established Ngāti Moki Trophy for Māori Leadership be aligned with the process for the University's premier awards and the Terms of Reference for the Awards Committee be amended as shown in the attachment to the report.
