- A fee waiver for post-graduates in 2024 is now being marketed.
- All universities have entered into a multi-employer agreement process to negotiate claims with the TEU and PSA.
- Currently 80% of one-on-one sessions with the Vice Chancellor subscribed by staff each month.

8. Lincoln University Students Association Report

The report was taken as read and touched on scholarship funds becoming inadequate to support students. The specificity of scholarship application processes can also be disproportionate to the value of a scholarship.

In response to concern about scholarships the Vice Chancellor commented that:

- The University operates in an environment where funding has not kept pace with inflation in recent years.
- Some stipends are insufficient to support elevated cost of living expenses incurred by students.
- If stipends increase, it may be necessary to offer less scholarships in total.
- Approximately half of scholarships are funded by external parties.
