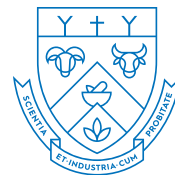

## Programme structure

Alternatively, you can start in either the February or July intake that will take 18 months to complete (full-time), allowing a break to be taken over the summer.

## Entry requirements

- New Zealand level 7 bachelor's degree or recognised equivalent, with a B average or better
- IELTS 6.5 (no individual band less than 6.0) or equivalent.

## Intake dates

Students can start in:

- November Summer School
- Semester 1 (mid February)
- Semester 2 (mid July).
