The Craigmore Sustainables and Wilson Family Sustainability for Primary Industries Scholarship is awarded for supporting postgraduate study and research in agriculture.

We are looking for a student who offers research interests that align with Craigmore's Sustainability Principles with the potential to conduct chosen research on a Craigmore dairy farm. We see this as an opportunity to establish an ongoing relationship with individuals whose research adds value to the agricultural industry.

Craigmore is a specialised investment manager of Aotearoa New Zealand agricultural assets, with a highly experienced team managing a mix of dairy, grazing, forestry, and horticultural properties covering in excess of 25,000 hectares valued at over \$1 billion.

Founded in 2009 by two New Zealand family farmers, the Elworthy and Cox families, Craigmore remains committed to the sustainability principles on which it was established. We strive to behave in ways that leave the world no worse off for our actions and allow the generations that follow to continue to earn a living from the land.

Our strategy is to build a diversified business in which New Zealand has an established reputation in the market. Farming is Craigmore's most mature business, comprising 23 dairy farms spread from North Canterbury to North Otago, and one support farm. These farms are overseen by Business Managers and for efficiencies are grouped into pods.

In 2010 Craigmore launched its forestry business focused on afforestation of marginal farmland and is an increasingly significant part of the portfolio. The first specialist horticulture business was established in 2016 focusing on the areas where New Zealand generates significant export earnings – kiwifruit, apples, and grapes. With large-scale developments in Hawke's Bay and Gisborne this investment is also driving revitalisation of rural communities, bringing jobs and instilling confidence in agriculture.

In 2022, Craigmore received the Fonterra Responsible Dairying Award and the John Wilson Memorial Trophy for demonstrating leadership in sustainable dairy farming. Thanks to this award, we have increased the number of scholarships offered.

Craigmore's head office based in Christchurch has a distinctive structure with its own financial, acquisitions, and operations specialists supporting the sector teams across the regions.

REGULATIONS

1. Purpose

The Craigmore Sustainables and Wilson Family Sustainability for Primary Industries Scholarship was established to support postgraduate study and research in agriculture and agricultural areas at Lincoln University.

2. Number/Value

One scholarship to the value of \$2,000 per annum shall be awarded.

3. Eligibility

- (1) Scholarships will be open to full-time students who are currently enrolled in a postgraduate qualification. The postgraduate study must include a research component.
- (2) Applicants may be New Zealand Citizens, Permanent Residents or International students.

4. Selection Criteria

The scholarship will be awarded based on the following criteria:

- (1) Research interests that align with the focus of Craigmore Sustainables farming business, as well as agriculture and related areas in New Zealand.
- (2) Current and future involvement with the agricultural industry in New Zealand.
- (3) Potential to complete the proposed qualification.

NB: Preference may be given to applicants whose research can be conducted on Craigmore Sustainables dairy farms.

5. Selection Committee

The scholarship shall be awarded by a selection committee comprising;

- (1) A representative of Craigmore Sustainables
- (2) The Convenor of the Lincoln University Scholarships Committee, or nominee
- (3) A representative from the Lincoln University Scholarships Committee with an understanding of New Zealand agriculture and agribusiness.

The selection committee may refrain from making an award if it finds no candidate of sufficient merit.

The selection committee may invite applicants to attend an interview as part of the selection process.

6. Tenure

Scholarships shall be tenable for one calendar year.

7. Programme of Research

During the tenure of the scholarship, every scholar shall be enrolled as a full-time student at Lincoln University.

8. Deferral of Study

No deferment is available for this scholarship.

9. Payments

- (1) The scholarship shall be paid upon successful registration in the appropriate postgraduate qualification.
- (2) Successful applicants shall pay their own tuition fees.

10. Co-Tenure

- (1) A scholarship shall be tenable with any other scholarship, bursary or award, provided the regulations of any other scholarship, bursary or award allow co-tenure.

11. Positions of Emolument

- (1) A scholar is expected to devote his or her whole time to studying for the required postgraduate qualification.
- (2) A scholar may hold a position of emolument while receiving a scholarship provided that he or she meets the University's requirements for registration as a full-time student for a postgraduate degree.

Note: In order to meet the university's requirements for registration as a full-time student, a scholar may work no more than ten hours per week during the academic year.

12. Extensions

Under no circumstances will an extension be granted beyond the maximum tenure of twelve months.

13. Conditions of Scholarship

- (1) Craigmore Sustainables may request the Scholar to provide a summary of their research during their tenure of the scholarship.
- (2) If, at any time, the scholarships office is satisfied that the scholar is not diligently pursuing his or her studies; or is not complying with the conditions of the scholarship; or is not making satisfactory progress, then they may suspend or terminate any scholarship or require the forfeiture of any proportion of the scholarship emolument.

14. Concessions

The Convenor of the selection committee may relax or modify the application of any of these regulations in special circumstances or in order to avoid hardship to any scholar or candidate for a scholarship.

15. Applications

Candidates shall submit applications no later than 31 March. Applications will be submitted on the form provided below.

These regulations shall take effect from 1 September 2023.

PRIVACY PROVISIONS

The information requested in this application form and your academic record will be used solely for the purposes of assessing your application for the Scholarship(s) for which you are applying. Personal information contained in this application will be made available to members of the Selection Committee for this award, the membership of which is detailed in the award regulations.

Lincoln University undertakes to store your application in a secure place in the event that you are successful in gaining an award or are selected as a reserve candidate for an award, and to destroy your application after a minimum of three months to preserve its confidentiality in the event that you are unsuccessful in gaining an award.

Should you have reason to believe that information held about you in either your application or your academic record is incorrect, you have the right of access to, and correction of, that information.

Personal references from the persons you have named are obtained on the strict understanding that they are confidential, and you may not have access to those reports without the written authorisation of the author. References will be stored for no longer than twelve months
